

# DEAR FRIENDS,

Our vision is to be the best service dog school in the world. We believe that being our best is an achievement worthy of our focus, resources, and efforts. And that being our best is the best gift we can offer to the people who rely on us to restore freedom, confidence, and dignity.

To achieve our vision, we've set our sights on five strategic priorities:

1. Extraordinary dogs
2. Services that transform lives
3. Financial strength to maximize our mission fulfillment, stability and growth
4. Exceptional staff and volunteers
5. A world-class infrastructure within the realm of working-dog organizations

In 2015, with these strategic priorities set firmly before us, we're on the right path. Here's a look into our accomplishments last year, seen through the eyes of our vision and mission.

## STRATEGIC PRIORITY 1: EXTRAORDINARY DOGS

Our dogs are elite athletes, and keeping them strong, healthy, and able to achieve peak performance is a strategy we take seriously. As we employ innovative and best practices, 2015 stands strong. We're creating extraordinary dogs through our cutting-edge work in the cryopreservation of breeding stock; our data-driven genetics and reproduction strategies; our advances in veterinary practices such as laser therapy, acupuncture, massage therapy, and microbiome transplant therapy; and our outstanding positive reinforcement-based socialization and training protocols. And our strong leadership role in the Assistance Dogs International North America Breeding Cooperative (ABC) strategically connects us with other service dog organizations to continually improve genetics and diversify the lines.

As the premier guide dog school in the country in genetics, reproduction, veterinary care, socialization, and training, we're maximizing our dogs' successes and longevity in working careers.

## STRATEGIC PRIORITY 2: SERVICES THAT TRANSFORM LIVES

Our school impacts our students and graduates through a myriad of highly rated services. Our on-campus services include education and accommodations for students who train in our 26-day guide dog classes and veterans who train in our 12-day service dog classes. We continue to maximize service through small classes, low student-to-trainer ratios, and highly individualized instruction. Off-site placement services encompass training individuals with their new guide dogs, service dogs, facility therapy dogs, and emotional support dogs in their own homes and communities. Last year, we placed over 100 dogs into working careers benefitting others.

But our services don't end with training and placements. We continue to provide the best possible follow-up service to graduates through personalized contact. Our extensive outreach and in-home services include support for over 450 active graduate teams. With a 99% student satisfaction rating and 96% graduate satisfaction rating, we're hitting a high mark of services that transform lives.

## STRATEGIC PRIORITY 3: FINANCIAL STRENGTH TO MAXIMIZE OUR MISSION FULFILLMENT, STABILITY, AND GROWTH

We're pleased to report that our finances are strong and our support base continues to grow. In 2015, we generated \$16.5 million in contributions, including \$9 million for capital projects. We invested \$.80 of every \$1.00 in our programs, and continue to remain the highest rated guide dog school in the nation on Charity Navigator, America's largest independent charity evaluator, with a score of 98.83% out of a possible 100%. And we continue to diversify revenue sources with new fundraising events and entrepreneurial activities.

## STRATEGIC PRIORITY 4: EXCEPTIONAL STAFF AND VOLUNTEERS

Our goal is to maximize staff and volunteer performance and satisfaction as we attract and retain world-class talent. In 2015, we provided an excellent working environment for over 100 employees, implementing a mentoring program for new-hires and expanding our training and immersion for a more successful onboarding experience. We also expanded our internship program to attract talented new candidates. Our number of core volunteers grew to over 1,000 and our volunteer hours represented a cost savings of more than \$12 million. In 2015, we enhanced our volunteer engagement by expanding the robust level of training we provide to volunteers.

## STRATEGIC PRIORITY 5: A WORLD-CLASS INFRASTRUCTURE WITHIN THE REALM OF WORKING-DOG ORGANIZATIONS

Creating the best guide dog school in the world demands a world-class infrastructure, and we are well on our way to replacing our aging facilities. In 2015 we broke ground and started construction on our Barpal – Hirst Student Center and our Puppy Academy. These new facilities have been designed with an intentional balance of quality and frugality, as we remain good stewards of our resources while providing the best possible outcomes.

Our new Student Center will dramatically enhance our service delivery model for our new and returning students, providing them with an environment much more conducive to learning and much more responsive to their needs while living on campus. And our new Puppy Academy will take our whelping program, puppy education, and early socialization strategies to a new level of excellence. Our Puppy Academy comprises a well-designed strategy to create better educated, more socialized puppies that become smarter, more confident working dogs.

As we pursue our vision and mission through these five strategic objectives, they provide a roadmap to the future. But meanwhile, our heart continues beating to the rhythm of our day-to-day operations, where we are privileged to watch small puppies transform to magnificent, skilled working dogs, and students transform to independent, confident people walking tall with the dignity they deserve.





# "HE'S CHANGED EVERYTHING FOR ME. I WOULDN'T TRADE HIM FOR ANYTHING."

"I was 34 days into my deployment to Afghanistan when I was blown up by two anti-armor mortars and shot in the abdomen. I was sitting up against the compound wall when we were attacked. My injuries sustained included shrapnel through the forehead into the brain; shrapnel to both eyes, and also to my cheek and chin; a flayed shoulder from my armpit to the top of my shoulder; and shrapnel scattered down my right arm. My right hand was mangled. A bullet from an AK47 went clear through my abdomen. I had a chunk of shrapnel in my rib cage and scattered shrapnel in both legs. I lost four and a half inches from my tibia.

I woke up in Walter Reed a week later. I had a traumatic brain injury but wasn't instantly blinded. I lost my sight a year later and they still don't know why. That's the million-dollar question.

From the first moment I met Zak, I couldn't describe it in words. If I need to go somewhere, he takes me there. He's changed everything for me. I wouldn't trade him for anything."
